# Rhode Island Agricultural Council

The Rhode Island Agricultural Council (RIAC) was formed in 1924, originally as the RI Agricultural Conference (the name was changed in 1958), to discuss the needs of agriculture in Rhode Island.

### **Our Mission**

- •Stimulate development of an interest in agriculture, horticulture, forestry, and allied interests and;
- Create an interest in rural life and the improvement of the rural community in Rhode Island;
- Effect a close relationship between representatives of agriculture with its allied interests and with commerce and industry;
- •Develop and carry out a complete program for efficient production and economical distribution of farm products in Rhode Island, and;
- •Coordinate all agencies interested in the welfare of agriculture in Rhode Island into one association from which unified efforts towards education, legislation and representation of agricultural interests of the state may emanate.

### **Specialty Crop Initiative**

The RIAC has been awarded a Specialty Crop Block Grant (SCBG) to enhance the visibility and viability of specialty crops in the marketplace. The USDA defines "specialty crops" as: "fruits and vegetables, tree nuts, dried fruits, and horticulture and nursery crops, including floriculture."

Any plants grown "for food, for medicinal purposes, and for aesthetic gratification" fall under this category. Also included in this definition are "wild" crops that have been brought under management or cultivation. Maple sugar/syrup, cranberries, blueberries, and mushrooms are examples.

Excluded from this definition are commodity crops, field crops, grains, livestock feed, bio-fuels, and federally-controlled substances.





### RIAC

### **Activities**

- •RIAC appoints members to the Agricultural Advisory Committee, which meets periodically with the DEM in an advisory capacity.
- •RIAC considers and awards grants to member organizations for the promotion of agriculture in RI.
- •RIAC meets three times a year at various locations to discuss member activities and agricultural issues.
- •RIAC executive committee meets separately several times per year and provides direction for the council.
- •RIAC advocates for RI agriculture through its presence at local and regional events.
